#### REPORT OF THE MUSIC COORDINATOR / ORGANIST

I will sing to the LORD as long as I live, I will praise my God while I have my being. (Psalm 104:33)

These words of the Psalmist encapsulate my life as a professional church worker, particularly a church musician. The work I do, and the work I enable others to do, is a truly gifted vocation: something that deeply reflects who I am and what brings me great joy. It is indeed a privilege to serve the people of Grace Lutheran Church as your Music Director. It is a privilege that seems even more enriched this year, as I have celebrated the completion of my fifteenth year in this position with you. We have spent five cycles of the three-year lectionary together. I have seen my children make their way through the Sunday School and Confirmation programs at Grace. I have been at many of your weddings and have watched young families grow before my eyes. I have watched baptized babies grow into healthy and inquisitive young men and women. I have been with you and helped you sing through your grief as your family members and friends have left this earth and taken their place with the saints in heaven. Through each of these journeys together the one constant has been the enduring faithfulness of a God who promises to bless those who put their trust in him. We are reminded throughout scripture that our journey is made together; we are not in this journey alone. We walk together, and are accompanied by a faithful God who loves us. That is, in fact, what worship is all about: Through our words and songs, we bring to life a celebration of each of the seasons of our lives together.

As I reflect more specifically on our last twelve months together, many fond memories fill my mind. We have continued to see new faces in each of our musical ensembles. Our worship cycle of a single family worship on Sunday morning and a regular congregation of Wednesday evening worshipers continue to feel positive. Liturgies celebrating God's gift of water, occasional outdoor worship services, and our Lenten series on "giftedness" have been memorable and meaningful for many. Our anticipation toward calling and receiving a new Senior Pastor occupied much of our thoughts and energies. One specific outcome of that anticipation was the creation of a notebook that in word and pictures shares what worship looks like at Grace Lutheran. This notebook was created to give insight to potential candidates, answering a variety of questions that they may have about our current practices. It was a labor of love to create, and I welcome your viewing of it. Although the anticipated outcome of the arrival of a senior pastor didn't come to fruition during the 2015 calendar year, we did not stand still and do nothing. I am so proud of how our congregation continues to flourish under the capable leadership of interim Pastor Janet White. I also continue to value the support I receive from Sherry Seberson in her fine work as Cherub Choir director. Additionally, I continue to find joy and fulfillment in serving in a variety of supportive musical roles within our public school district 241 and within areas of music and worship within our Southeastern Minnesota Synod.

A personal highlight of last year would definitely be the opportunity that I was given by the Synod to be our representative at the ELCA *Worship Jubilee* in Atlanta, Georgia last summer. Five days of excellent music making, worship, and comradery with colleagues old and new really nurtured me and filled me with new-kindled excitement and energy. I have looked forward to sharing some of those newly discovered worship elements with the people of Grace.

As I look ahead to this new year, I trust that as we seek to be faithful in our worship lives together, God will continue to bless us, as God has in the past, and will open up for us an exciting and creative future, full of hope and fulfilled promises. That is my prayer for each of us, that we remain faithfully patient and open to the nudging guidance of God's spirit among us. Thank you for the continued opportunity to serve you in my role as your Church Musician.

#### REPORT OF THE EDUCATION DIRECTOR / EDUCATION AND LIBRARY REPORT

I cannot express enough the depth of my gratitude for the faithful and passionate volunteers here at Grace. These folks are willing to step up and help out, even with their super busy schedules. They share their time with our students and it really does make a huge difference.

September of 2015 marked my fourth year here at Grace I am blessed to work with the students and awesome families we have. We have done some growing over the last few years. When I started in September of 2011 we were already using the rotational method for Sunday mornings, we continued with that but discovered that was not the right fit for Grace. With the impute of families and classroom leaders we found more of a large group small group curriculum that was based on themes of the Bible vs stories, that wasn't the right fit either. In conversations with families and classroom leaders, in 2014 we transitioned into a more traditional classroom model that included experiential ideas and videos about those traditional stories we all grew up with. In 2015 we have continued using this same curriculum it is a better fit for Grace Lutheran families. During all that we changed the name of Sunday mornings to Faith Exploration, at the time of the change many meetings were offered on this change along with other information. The new name reflects the future of Faith Formation for our children, youth and families. It's been wonderful to see the increased interest in learning about our faith.

The Treehouse (5<sup>th</sup> & 6<sup>th</sup> graders) have some new great additional activities specifically for them. We had 3 summer events for them this year along with Youth Blast at GEV.

The Children's Christmas program changed to 11:30 last year and we continued that again this year. The timing works better for families and our littlest students. Brenda Herr has been doing a fantastic job with this and we are very grateful to have her. We hope she will come back again next year.

Our Faith Steps for Families classes have been very successful, these fit well with the growing interest and need for more learning opportunities for families. Many have shared that they love the classes and the opportunity to learn together with their child things they have forgotten when they were young. Faith Steps for Families classes provide an excellent environment to



learn and grow together. Research shows us often when families do have time together the discussion is focused on did you get things done in order to be ready for next day, parents are getting through the mealtime, then homework, then bedtime, then the dishes and the laundry whew! We strive to help families learn together by providing resources, intergenerational events, classes and information.

VBS is a favorite time here at Grace. It's a week of being a kid and experiencing Jesus as a kid. We do crazy dances, have our imaginations inspired, go on Bible adventures, eat great snacks (a favorite tradition) and join in awesome games all centered around Jesus. A great way to learn and be around others sharing the same faith as you who are having a blast too. We are exploring the idea of daytime VBS for summer 2016.

Our library has added more books, a few music CD's, DVD's and resources for us. In the regular monthly *Grace Notes* article we have been including online resources for Faith Formation along with book and movie reviews. We are working on a section for the website that will have links and other resources for Faith Formation, watch for that to come in 2016.

Over the summer we added a trip to wilderness Canoe Base this was open to  $7^{th}$  grade  $-9^{th}$  we sent 9 students and 1 chaperone, they came back with praise and wanting to go again. This is offered again in 2016 for those entering  $7^{th} - 12^{th}$ .

I love working more with all of our confirmation students. Our Faith Guide program has incorporated all the stages that were part of the original design. Watching the students and their Faith Guides having conversations after worship is inspiring. We added going to Winter Warm Up sponsored by local churches for all confirmation students in Southern MN, this has inspiring guest speakers each year. Our curriculum is relevant to students of today and challenges them to find their faith and own it. Relating faith with their current life and how to take with them for a lifetime. Our goal is to inspire them to be curious, keep learning and participate in their church as leaders. For the past few years I have been participating the Confirmation Project. The Confirmation Project is a collaborative research effort among five denominations to learn more about confirmation and equivalent practices across the United States. We are interested in how the experience of confirmation serves to intensify Christian identity and integrate belief into daily life. I have had an opportunity to join with many colleagues in this ongoing discussion and learn many things that are working and not working in several congregations.

Research also shows us that families have less and less time together to share and talk about our faith, those traditional lines of storytelling and sharing with older generations and within the family are missing replaced by frantic schedules. Outside activities sports, dance and other groups have really grown to be the place to be social with others, the places people congregate. The church is no longer the social place to gather. So where do we fit in now and how can we continue to be relevant to families? There are numerous studies on this, it has been one of my main areas of concern and research for the last three years. This past year I have been working on my certification in Children, Youth and Family ministry in order to provide better equipped programs here at Grace.

Back to the question how do we continue to be relevant to families? What is our vision and mission regarding Faith Formation and how do we get there? This is the topic for a group we are creating Children, Youth and Family Ministry Team. The duties of the Children Youth and Family Team include, but are not limited to:

- create and cast ministry vision
- develop programs which serve the purpose of educational ministry and meet the needs and interests of the congregation's membership
- coordinate and evaluate ministry programs

We are looking for 8-10 adults for this team. If you have some passion for this area of our ministries here at Grace I highly encourage you be a part of this team. You may contact me for further information.

Watch for upcoming surveys to give your feedback regarding the educational ministries here at Grace. Your valuable feedback will assist the team with providing programing that best suits the needs and resources here at Grace.

#### REPORT OF THE PARISH NURSE

Let your light so shine before others that they may see your good works and glorify your Father in heaven. (Matthew 5:16)

As your Parish Nurse, I am a Registered Nurse who holds a current license to practice professional nursing while continuing to meet the state requirements for education. As your Parish Nurse I had to previously complete an endorsed Parish Nurse program prior to accepting the position here at Grace Lutheran, and today I will say that I am honored to be a part of the pastoral ministry here at Grace.

A Parish Nurse is an Integrator of Faith and Health, reminding people to care for their body, mind and spirit.

A Parish Nurse is a Health Educator. By utilizing the monthly Grace Notes I am able to offer an article utilizing a holistic approach for good health, along with one-on-ones or to small groups which allows me to encourage understanding as to the connection of faith and well-being.

A Parish Nurse is a Personal Health Counselor. I am able to discuss health problems with parishioners, while giving clarity and support. I am able to make home, hospital and nursing home visits as needed. In 2015 I made on average 37 contacts through face-to-face visits, phone calls, email messaging, and small group involvements.

A Parish Nurse is a Referral Agent. I have been able to assist others while navigating the health care system and making referrals when necessary. I not only network with area Parish Nurses, I also work with community agencies, establishing resources and networks that assist with the well-being of the congregation.

A Parish Nurse is a Health Advocate. The nurse assists with healthcare assessments, referrals and decisions when requested or needed. At times my position has required making phone calls to involve family members, or provide transportation and accompanying a member to a health care facility and attending their MD appointments.

A Parish Nurse is a Developer of Small Groups. Currently at Grace we have a women's and men's grief support group that meets on the fourth Monday of the month offering support for those who are grieving, while offering hope to those in despair or transition with their own health care needs, relationships, loss of job or transitions in life. The Parish Nurse also encourages fellowship with others by becoming involved with the Friends Group that meets the second Sunday evening for a time of fun, games and fellowship with others.

This past year I also started a small group ministry with our members that reside at Knutson Place to assist them in feeling connected to the church by offering a time of fellowship and bringing the Sacrament of Communion on a monthly basis.

A Parish Nurse is the Trainer of Volunteers. Christ called all to be disciples of his ministry. The Health Cabinet continues to support the ministry of health and wholeness by assisting with the healing services throughout the year and also by providing a time of fellowship, and support to others following the Blue Christmas service, a service of hope and remembering for those who find it difficult to be joyful at Christmas time. I am grateful to our volunteers that bake cookies allowing the Parish Nurse to share a small gift of sweets or a choice of fruit when visiting. We also have talented volunteers that will knit and crochet not only baby booties and baby caps, but also prayer shawls that can be given as a Gift of Love from our congregation.

The Visitation Team. I am currently seeking volunteers for a wonderful and rewarding opportunity to minister to others while sharing a caring heart and bringing communion to those homebound or living in nursing homes. The Visitation Team meets only every other month on the first Monday at 4:00pm to offer updates and organize visits to our homebound. Let your light shine before others and join us in this important ministry as we 'Bring People Together and Become Disciples for Christ.' Please call myself or the church office if you are willing to become a part of this ministry.

# GRACE LUTHERAN CHURCH Minutes of the Sixty-eighth Annual Meeting January 25, 2015

Senior Pastor Report by Pastor Janet White: Pastor Janet noted there has been a lot of change and transition this past year. Pastor Janet said we have a wonderful church and thanked everyone for their support. She thanked the staff. The Call Committee is working hard, please be patient. Pastor Janet is working on the procedures and practices of the church. There are items that are not normal and she is working with the proper people to make them right. She is looking forward to working with the new Council this upcoming year.

Treasurer's Report: Pastor Janet and Jim Westeng presented the treasurer's report. There are many different areas in the budget where there is mixing of the funds. Everything is being accounted for and we can track where it is being spent. The goal is to have the ministry teams and staff know what their budget is and control their expenditures. #### PRESIDENT'S REPORT

This past year your church council worked not only on the regular business you would expect to come before the council, but also effectively navigated through multiple difficult issues effectively, resulting in a stronger council and congregation. The council also found time to work on three additional areas: 1) increasing transparency, 2) enhancing trust, and 3) identifying an effective approach to discern the common values, assets, and passion of the congregation of Grace Lutheran Church.

Why transparency? A transparent environment welcomes and encourages an open respectful discussion on issues and ideas. In many ways the council has succeeded in an establishing a transparent environment where congregation members are well informed and comfortable in expressing their ideas and personal passions. Moreover, in some areas we need to work harder in understanding others who still feel alienated in one way or another.

Trust is a cornerstone and foundational to relationships and organizations. Enhancing the trust, we have for each other and for the governing entities at Grace Lutheran are critical, in order to move toward an understanding of what God is calling us to do as a congregation. Yes, trust must be earned and communication is a key piece to providing a path to a trusting environment.

Identifying an effective approach to discern the common values, assets, and passions of our congregation provided the opportunity to apply for Synod's LEAD initiative. LEAD stands for Living Every Day as Disciples of God. The process is very intentional and thoroughly scripted to help congregations analyze if they are growing, becoming, stalled and/or out of breath. The LEAD program then provides direction on how to determine the proper course of action. Through the assessment taken last year, Grace Lutheran was identified as a congregation that is becoming and growing. In addition, one of the strongest behaviors identified of our congregation was listening. The LEAD group's first task is to build on this strength. This group is learning what it means to be great listeners and how to apply the skills they will learn to help the congregation of Grace Lutheran and our neighborhood to identify our common values, assets, and passions in order to understand what God is calling us to do.

Not all of this work could have been accomplished if it had not been for the strength and talents of the members of your church council. Your council members have exhibited great strength and insight in working through several difficult situations this year. They have served as a valuable role model to the congregation. They are a cohesive, confident, and wise board and I am honored to serve with them.

#### **GRACE FOUNDATION, INC.**

The purpose of the Grace Lutheran Church Foundation continues to be to receive from Grace Lutheran members or from the public, gifts, bequests or properties as may from time to time be given. Its purpose is to invest and administer such gifts with proper regard for their safety and interest according to the will of the membership and the designation of the donors. Interest accrued from the funds and investment returns including realized and unrealized capital gains controlled by the Foundation may be designated by the board to be used for missions, education or other specific projects of Grace Lutheran Church in its gospel outreach.

In 2015 we had another very busy year and completed many projects which included the formation of a Distribution/Request subcommittee to go along with the Financial and Farmland committees that were formed in 2014. With the formation of subcommittees it has helped immensely to a more efficient streamlined approach. We also created job descriptions for each Foundation officer position and for the subcommittees. These are just a snapshot of many tasks that the Foundation completed in 2015.

An in-house Foundation audit was completed by Dave Lundak on Feb. 12, 2015, and the findings were that the balance statements and banking records accurately reflect the financial position and activities for the year ending, Dec. 31, 2014.

Monetary support was again given in the form of scholarships to students from our congregation attending Lutheran colleges; 5 students were awarded scholarships. The Foundation once again supported the Vacation Bible School, youth camp expenses such as Good Earth Village, Boundary Waters Camp, Girls of Grace, and many other ministries.

The main source of income again in 2015 was the farmland rental monies. In 2016 we will be entering the last year of a two-year lease with our renter and we will be entering year #2 of a 15 year CRP contract with the USDA.

As we look ahead to 2016, we will prayerfully consider the needs of Grace Lutheran Church and continue to provide appropriate financial support to the needs of the congregation, its ministry programs and gospel outreach.

The Foundation would like to thank Julie Drommerhausen for her tremendous service on the Foundation as her second three-year term is expiring. We would also like to thank Perry Loge for filling in as our treasurer over the last year as an advisory position until we found a replacement for that position.

#### **BUILDING, EQUIPMENT AND GROUNDS TEAM**

Our church has seen many challenges with our building in the past year. As most of you are likely aware, the highest priority has been with the heating system. It has become unfeasible to continue to repair and maintain. You may also be aware that we are seeking proposals to replace our current boilers with new steam boilers or convert to hot water heat. A few of the estimates we have obtained indicate we can expect to spend in the neighborhood of \$200,000 depending on the option we choose.

We recommended to the Council to consider a motion to create a designated fund for this purpose, and the Council approved it at the last meeting. Our goal will be to raise the amount needed to get the project done in the summer of 2018. This is an aggressive goal, but we are optimistic that we will achieve it.

The committee also received an insurance audit to explore what improvements would need to be made to possibly lower our premiums. Many of the items have already been done, and there are many more that hope to be completed in the next year.

The Personnel Team did an outstanding job with the hire of Darin LaFrance as our new Building Superintendent. He has been great at communicating with our committee and getting projects done.

Rod Anderson has maintained a priority list for the committee that we consider at our meetings to keep track of what has been done and what needs to be done. Some of the other improvements in the past year have included a new garbage disposal, water softener, motion light switches, GFCI outlets, emergency exit signs, replacement of steam traps on radiators, and the mud leg on one of the boilers. Thanks to Rod, and all who helped maintain the lawn with their time and saved an estimated \$3000.

Please contact one of our committee members with comments or concerns you may have regarding our beautiful property. I believe it is the most attractive church in our community, and it is our goal to keep it that way.

#### LIFE AND GROWTH / SOCIAL CONCERNS MINISTRY TEAM

The ministry team typically meets monthly prior to the Council meeting. This year, the team continued emphasis on a number of on-going projects and activities. The Synod's goal to wipe out food insufficiency in southeastern Minnesota was previously adopted by this team and has continued through the year with targeted food drives every other month. During the past year, the following has been donated by the generous Grace family: 225 pounds of pasta and sauces, 70 boxes of cereal, 59 pounds of fresh and canned fruit, 97 pounds of school snacks delivered to the 4 elementary schools, 209 pounds of vegetables, and a yet to be weighed load of rice. A second order was placed for the t-shirts, polo shirts and bags inscribed with the specially created Grace logo. An inter-generational 'Stay and Play' event was held in January. Another was going to be held in the summer but a new plan was pursued instead. There were two Voyagers events planned for the year. In April, a group went to Faribault, touring the woolen mills, the art center and the Cheese Cave restaurant. In October, a group went on a bus trip to see *Mary Poppins* at Chanhassen Dinner Theater. The early morning coffee fellowship on the first Sunday of each month featuring the *Fair Trade* coffee being sold by the Mission Team was continued this year with very positive feedback. The team assisted with the new member Sunday in February.

New endeavors for the year included the initiation of CAP – Cinema and Potluck nights. Following a potluck meal and fellowship, a movie is introduced and viewed followed by interesting and thought-provoking discussion. A communication board was mounted in the gathering space. This provides a way for Grace family members to request prayers/material needs/assistance, to be able to offer assistance and to share highlights in the lives of family and friends. A joint effort with the Mission Team provided a breakfast for the bikers and staffers for the Habitat for Humanity bike ride. A new intergenerational activity called 'God's Work – Our Hands' was held on Rally Sunday. Teams worked to prepare sandwiches for the Salvation Army and The Rock, to provide entertainment for residents of Oak Park Place and Thorne Crest, to clean up the shoreline of Fountain Lake and to care for the lawns and gardens at Grace. This was followed by a meal for all on the church lawn. A presentation/discussion about use of technology and media was made to the Church Council. This has been moved to the newly formed Technology Committee.

The team welcomes new members and new ideas to continue moving forward with doing God's work with our hands and Bringing People Together and Becoming Disciples for Christ.

The Mission Ministry Team meets monthly on the first Wednesday. The areas of service this team assists with are as follows:

The Fair Trade Equal Exchange products which include coffee, tea, cocoa, baking cocoa, and olive oil which is sold from our kiosk on the first Sunday of the month. This year we have included the individual coffee brew cups, the Salvation Army Angel Tree, the Garden Table, the Hawthorne School project, Habitat for Humanity, Channel One commodity distribution, Thanksgiving food project, the March Minnesota FoodShare project, the International Health Partners of U.S. and Tanzania and missions in Latvia, Tanzania, and the Russian Seminary.

This past year the Mission Team hosted Denny & Paula Lofstrom from the IHP (International Health Partners of U.S. and Tanzania). They will return again next October. The Angel Tree hosted 100 children's needs and these were all filled with gifts. Many fine fruits and vegetables were shared on the Garden Table and the donations were included in the Food Shelf donations. The World Hunger donations totaled \$2,433.25 and were sent to the Synod. Volunteers helping with local commodity distribution included seven Grace Lutheran members. This group serves between 60 and 70 seniors every month. The March Minnesota FoodShare project totaled 84 pounds of food and \$1,566.00 which went to the Ecumenical Food Shelf. Our annual Thanksgiving food drive totaled 401 pounds.

The amazing speakers were able to catch the attention of everyone and make them think about their faith journey in life. #### Program Update:

- We hosted our second Launch Project series this fall, where our speakers inspired church leaders to engage their ministry differently. We welcomed Becca Stevens, Carl W. Kenney II, and Brian McLaren, who shared their unique experiences and perspectives on life, the church, community, theology, and what it means to be a Christian in this day and age. Our 65 participants walked away with a renewed sense of curiosity and drive for using what they learned to benefit their own congregations and communities. It was a positive and growth-oriented experience, and we are eager to see what the 2016 Launch Project will bring.
- In Summer 2015, our theme was *Light the Way*. Campers learned how to see God's light at work in the world through the *Blaze* of creation, the *Spark* from Jesus that created a movement of love, the God-given unique lights that *Glow* inside each of us, and the way we nourish and *Shine* that light into the world. We are God's light.
- We care deeply about our campers' interests and needs, so in Summer 2015 we introduced six new programs to help meet the needs of the families we serve. Imago Dei was an arts camp that brought in guest artists to explore God at work through art and creativity. Village Kids, an on-site day camp that offered daily transportation from Rochester and Austin to Good Earth Village, allowed parents to enjoy the convenience of a day camp while their kids enjoyed the excitement of camp here at Good Earth Village. Camp 45 gave four and five year olds the opportunity to experience camp for the first time alongside their parents or grandparents. Off the Grid, a half-week program where campers head into the wild and set up camp in a new secret location, provided a shorter option for older campers who preferred not to stay an entire week. Glow in the Dark Camp gave middle school campers the chance to experience God's light in a whole new way by flipping their schedules to stay up all night because God's light never goes out.

- **Family Camp Weekend** gave families a time and place to play, relax, learn, explore, and worship together.
- A highlight of our summer was an increase in camper numbers for our On the Road and Day Camp programs. We have enjoyed seeing God at work in your communities, and are happy that we can continue to be a resource for you, both here at camp and in your own churches and communities.
- Our Youth Blast programs continue to grow and develop. We offered one Youth Blast in January, one in the spring, and three this fall. One of our fall Youth Blasts had over 60 campers in attendance it was a blast! Our fall Youth Blast theme was Awake! Arise! Shine! and campers learned about what it means to notice and share God's love in the world, even when they are feeling scared and unsure (as Jesus' disciples often did).
- We hosted our First Annual VIP Camper Weekend in November. This was a free weekend retreat offered to all campers who had pre-registered for Summer 2016. The campers played in the snow, had an exclusive taste testing of potential summer snacks, got a peek into the lives of the counselors during the school year, and shared their ideas of what makes an ideal week at summer camp.
- This year we began construction on several new cabins in Old Town. The new cabins will match the "Old West" style and spirit of the rest of Old Town, and will feature bathrooms and showers, as well as a large boardwalk-style deck connecting them. We look forward to their completion and the positive impact it will have on our ministry.
- Our second annual Good Gifts Gala was a successful night of support for our mission. Close to 120 people attended, and over \$60,000 in income was generated. We're deeply grateful for the hard work of our planning team, everyone who donated items for the auction, and all of the attendees who joined us in celebrating the ministry of Good Earth Village. Your generosity allows our ministry to spread.



2015 was a great year for ministry at Good Earth Village. We have faced many changes in past months, but these changes have given us the ability to see the many opportunities for efficiency and growth available to us. With new leadership and a fresh outlook on our ministry, we are challenged to continue to find innovative and effective ways of sharing our mission with the world around us.

#### Financial Update:

- Thanks to a generous and unexpected estate gift, we were able to end the year "in the black." Our final audit report will be available at the time of our annual meeting (February 21).
- Long-time supporters of Good Earth Village know that the tuition charged to summer campers doesn't cover the total costs of providing a week of camp. We continue to believe in the importance of making leadership development programs available to kids from all walks of life, and we're committed to providing financial assistance to those who need it.
- In 2015, we used tiered pricing, which allows parents to choose the price they wish to pay for summer camp. No matter which price they pay, they're eligible to request scholarship funds. This makes it possible for families to pay the full cost if they can afford it, while making reduced fees available for those who need them. This is one
- way we can help to ensure that resources given to the ministry are used in the most effective way possible making camp happen for kids who wouldn't otherwise have the opportunity. We saw success in this pricing method in 2015, as our income from camper tuition remained fairly stable despite varying camper numbers.
- The success of tiered pricing and a rise in Day Camp numbers led to a slight incline in overall summer income.
- As mentioned in our program update, Old Town is under construction! This project is being funded entirely by "new money," such as grants and designated funds. No operating funds will be used to fund the project. Thanks to the leadership of Dianna Parks, our new Executive Director, we are halfway to our fundraising goal for the Old Town project. We look forward to its completion with eager eyes.

2015 was a year of huge advances in the way we deliver on our purpose – creating Christian leaders who will change the world. We're proud of the work we've done and confident of the transformation we witnessed in people's lives and work. Thank you for making this ministry happen, and for your ongoing involvement – financial support, prayers, volunteerism and participation. We couldn't do it without the support of our member congregations and passionate supporters.
