Youth Director Report

2020 was a long year. It was the year of adapting to a new way of living around a pandemic and doing things we never thought we would be doing a year ago. Ashley Kuhlman, Youth Director

Children, Youth and Family

This team provides input and direction on programming and faith formation opportunities at Grace. The team was advised by Pastor Jennifer Gonsalves and our Youth Director, Ashley Kuhlman.

Children's Ministry:

- Flexibility was the word of the year for Sunday School. As at different times of the year Sunday School met weekly in Fellowship Hall, outdoors and on Zoom. During the fall kits were sent home with Bible stories and other activities
- We would like to thank Kate Dahl for her many years of service as our Pre-K teacher as she has stepped down from that role to serve our church in other ways.
- At-Home Vacation Bible School was a great success. The theme was "Christmas in July," and each
 week in July, a present containing materials for worship, Bible study, craft, an outdoor activity, and a
 family discussion was dropped off at homes of Pre-K 6th Graders. Members from Grace helped
 with worship and crafts and we had 57 children participate.
- First Communion was rescheduled for the fall due to the stay-at-home order. Seven 6th graders and their families participated in communion instruction and celebrated their First Communion on Reformation Sunday.
- Preschoolers received a SPARK Story Bible and 3rd Graders received a Deep Blue Common English Bible as part of the Stepping Stone Ministry in the fall.
- 26 families received Advent kits to assist our families in spending time together to pray and talk about God while preparing for Christmas. Each kit contained materials to make their own Advent wreath, daily devotional cards, nativity stickers and more.
- Deacon Bob Tewes wrote, composed music and created a video for an original Christmas program titled, "A Christmas Celebration." This was done in a video format and shown during our Christmas Eve Family Service. Eighteen youth participated and did an amazing job.

Youth Ministry:

- Fifteen youth were welcomed into our Confirmation program this fall and 16 youth were confirmed in October
- Confirmation curriculum has continued to be created by staff to allow more learning styles and time for deeper discussion. This curriculum involves youth rotating through three stations based on that evening's theme (including at least one station led by a pastor or Grace staff). Due to COVID-19, adjustments have been made, including having youth remain in their small group during the duration of in-person confirmation and having confirmation over Zoom. We are thankful for the nine small group leaders and several other volunteers that have helped with our programming this year.
- 9th graders spent the fall reflecting on the baptismal promises on Sunday mornings and creating their faith projects as they prepared for their Confirmation Sunday.
- Current 8th graders were unable to attend Confirmation Camp this summer due to COVID-19. Looking for alternatives for the upcoming year.

Children, Youth and Family Continued

- Four youth and Ashley traveled to Northern Wisconsin for a week-long canoe trip through Camp Amnicon. Along with two wilderness guides, they traveled 30 miles down the Flambeau River and camped along the way. The youth got to experience sleeping in hammocks, whitewater rapids, Bible studies, cooking over a fire, no technology and spending some time on the shores of Lake Superior. High schoolers shared their experience in a video posted on the Grace Lutheran Facebook page.
- Baccalaureate was celebrated at an outdoor worship in July. Grace Lutheran had 19 youth graduate from high school this year.
- Service & Fellowship Events have included going to Mount Kato, bonfires, and playing Z-Tag. The High School Youth Group met both in person and online this year.
- Plans for summer camp, confirmation camp and a high school summer trip in 2021 are still to be determined.

Family Ministry

• Due to the impact of COVID-19, we were unable to gather for Family Ministry events this year.

Parish Nurse Report

Jeremiah 29:11

"For I know the plans I have for you," declares the Lord, "plans to prosper you and not to harm you, plans to give you hope and a future."

The parish nurse ministry at Grace Lutheran is a holistic ministry, reflecting the ministry of Jesus Christ, who healed the "Whole" person by caring for their physical, emotional, and spiritual needs. His ministry was a healing ministry as he led his disciples by example.

Mission Statement – The mission of the Grace Lutheran Parish Nurse is to help all experience God's grace, love, and healing by addressing their physical, emotional, and spiritual needs.

My services as parish nurse are to provide 10 hours weekly to the congregation in the way of home visits, health education, assessment and referrals for care and benefits, emotional support, and spiritual care using the "wholistic approach."

In January, the parish nurse schedules resumed with the 'grief support groups' that met monthly on the fourth Monday. There were also meetings with the Health Cabinet, who supports the parish nurse ministry, along with the visitation committee, who ensure that members receive communion on a regular basis and providing fellowship, while bringing church to our homebound. The Health Cabinet and visitation team both meet six times per year on the first Monday of the month, with an ongoing need for volunteers to support both these ministries.

In February, we started to hear of the Corona Virus, thinking it may not affect us in the Midwest. Little did we know that we would soon all be affected and that a new normal would be needed to protect us. As the weeks and months have passed, we can be so thankful for our researchers, medical teams, and front-line workers that have learned increasingly more about the virus and how to treat the symptoms, and now on the horizon, a vaccine to irradicate the ever-changing mutation of this virus.

On March 16, 2020, I was informed at both my jobs that I would be working from home. The in-home and nursing home visits were put on hold, and we soon found our positions looking very different. I struggle with technology, but quickly was introduced to Zoom and Microsoft Teams meetings. This was quite stressful and challenging for me, but it's quite amazing how we can meet for staff meetings, support, and planning. The way worship has changed has been incredibly amazing. The difficult part of my job was now supporting the many members who do not have this technology or the ability to join worship virtually and stay connected. We all know how difficult quarantine days became. We soon found that our entire world was different, from distance learning, businesses closed, shortages. Even death was looking different as we were not able to be with our loved ones; and funerals, as we have known and practiced, were not the same. Grief now looks vastly different without the support of family and friends to surround us during this challenging time.

My first burst of cards and letters went out immediately to our homebound, nursing home residents, and many members to inform them of the many changes that were evolving and the plan to keep everyone safe, and yet to assure them that staff at Grace were available to them. I made many phone calls to soothe emotions and fears, while offering services to provide them with personal needs items, food, hand sanitizers and facial masks, while educating their use for safety.

Parish Nurse Report Continued

As a Thrivent member, I have applied and received Thrivent Action Team Grants as part of community outreach that has helped to fund activities in the church, such as the purchase of supplies for the prayer shawl ministry, and most recently, been able to provide a small care package of love that consisted of some paper products, small meals and comfort food, facial masks, and hand sanitizer, along with prayer shawls to some of our members that have struggled with grief and loss, loneliness, and frustration with our world in the midst of the pandemic, along with some of our homebound members. If you are not taking advantage of Thrivent programs, you may want to contact your Thrivent agent to learn how to be a part of this community outreach program that can benefit our community and our church.

I have continued to offer support by making phone calls, sending cards of support, and adapting game plans for church members to maintain their safety. I have attempted to acknowledge holidays, Veterans Day, church events, and seasonal changes to stay connected with our members as much as possible. Thank you to a couple very generous individuals that offered greeting cards throughout these months. I have used, re-used, and recycled greeting cards to share with others and provide 'snail mail' in an ever-changing social media world.

In December, I took on the challenge to send a Christmas card to every active member, including a signed staff card, special seasonal scripture table cards, and the invitation to call on Grace staff if they needed spiritual support. I also sent cards of remembrance to those that lost loved ones over the past year, with encouragement to join the virtual 'Blue Christmas Service of Hope.' This involved 500+ cards that were sent out to Grace family members and their loved ones in a way to let them know that they are not forgotten and certainly remembered in our prayers. I encourage all of you to reach out to others with a phone call, card, or other means of social media to stay connected and offer emotional support for all.

My plans for 2021 will be to keep our members as safe as possible, and hope to resume my normal face -to-face visits, meetings, and support groups when we are given the okay for safe return of activities. If you have any questions or concerns, please call the church office and leave a message. I will return information as I have it available. Please stay safe.

Capital Campaign

The Capital Campaign continued into 2020 with the restroom project being the last initiative to be completed. Grace members generously gave throughout the year to support the effort, but then we faced a challenge. As bids were being collected for plumbing, electrical, and general contracting work, the Church Council examined the complete plans for the main floor and lower-level restrooms. A decision was made to do the entire project verses splitting it up into phases. In addition, as Grace examined the unused and underused space on each level, the Council realized that there was an opportunity to design a project that would accommodate the larger events that we regularly host as a church, such as weddings, regional conferences, and funerals.

With these strategic decisions being made, the Council realized that the funds collected through the campaign were inadequate to cover the costs. Outreach was done with the Grace Foundation and they approved a major gift towards the effort and a match of congregational gifts. Our focus for Grace has been HEART, one of LEAD's core convictions.

"HEART: Listens for God's leading in mission, service, and doing justice in the world, neighborhood, and congregation."

Our LEAD group continues to focus on God's love through the Food For Backpack (FFB) program. We pray our journey with this program will continue to serve the needs of children with food insecurities in our community.

Our fourth year with the Food For Backpack program has been a bit unusual with the pandemic. Distributing food has been handled differently as our school social workers have worked hard to make sure the food is offered to those in need. This year's total students have fluctuated some with our most recent total of 372, down about 75 students from last year's average, but still showing a huge need in our community. For purposes of planning and grant writing, our budget was \$67,860, which was based on serving 500 students. It's not surprising that numbers have been different than expected with how the schools have had to operate during these uncertain times.

We at Grace continue to partner with Zion to serve the children of Hawthorne Elementary; presently we are serving 77 students. First Lutheran and Hayward Lutheran support the students of Halverson. Ascension continues their support of Sibley, and United Methodist supports Southwest Middle School. This year we welcome Caleb Flugum, from One Love Rising, joining Crossroads to support Lakeview Elementary. Thanks go out to ALL these congregations, their volunteers, and with the effort of each school social worker. Through their efforts we are able to provide this needed program in our community.

The LEAD group extends a deeply felt "Thank You" to everyone who has so generously supported the Food For Backpack (FFB) program through funding, words of encouragement and prayers. This special gratitude also goes to the many Grace volunteers who have offered their services to support this program, as well.

Life and Growth/Social Concerns Ministry Team

The year 2020 began as years before – the Life and Growth team met once monthly, typically prior to the Church Council meeting. Planning for the year began, but activities were soon curtailed with the arrival of the COVID-19 pandemic. The needs of people within the church and community continued and possibly increased, but meeting those needs became a challenge as gathering with others was extremely limited. Some of the activities only reached the planning stage, while others were completed. They include:

- Enough Food For All campaign: In February, easy-to-prepare packaged meals were collected. In April, paper products and toiletries were requested, but very little was collected as church activities went online. The campaign was picked up again with a reverse Advent calendar – a food item collected for each day of Advent.
- Voyagers Trip: A bus trip to Chanhassen was planned to see The Music Man. This, however, had to be cancelled.
- Bible Study opportunity: The 4-week Sunday morning Bible study has been well received over the last years and planning was underway for a study in September/October. The topic of homelessness was being explored. This, too, was put on hold.
- The muffin ministry (in its new form of any kind of treats/fruits) was intermittent since March. Each month, the leaders at Youth for Christ would let the team know if there was a need for any treats. For a couple of months, fruit was provided for the bag lunches The Rock made available. When young folks were starting to return, treats were provided but then another shut down occurred. The team has remained ready to provide as the need returns.
- Red Cross Blood Drive The team agreed to host one drive during the shutdown in coordination
 with the Sheriff's Department as they were not able to host on their site. Grace staff members served
 as the volunteers for this drive. COVID-19 precautions were carried out as directed by the Red
 Cross.
- Two drive thru food fund donations were held in coordination with the Mission Team. Funds and food collected were divided between the Ecumenical Food Pantry and the Salvation Army Food Shelf.
- The team is looking forward to returning to more normal activities in the year ahead. New members
 are welcome to join in the mission at Grace of Bringing People Together and Becoming Disciples for
 Christ.

Mission Ministry

The Mission Ministry team met on the first Wednesday of the month until the church building was closed due to the Covid 19 pandemic. After that time, meetings and planning were accomplished through phone calls and emails. Because of the pandemic, the activities typically carried out by this team were limited. Those efforts that were accomplished are as follows:

- Fair Trade Equal Exchange coffee, tea, cocoa, candy bars and olive oil were sold the first Sunday of the months while the church building was open.
- The Ministry Team in cooperation with the Life and Growth Ministry Team hosted two drive thru food fund donation events. The food and funds collected were divided between the Ecumenical Food Pantry and the Salvation Army Food Shelf.
- Planning was initiated to set up a meal preparation team to support the local foster care program. This was put on hold as the church building closed.
- Dissemination of the funds gathered in 2020 through the undesignated giving (half of one percent of this amount) and through Ministry for a Day will be as follows:
 - \$515.40 to St. Catherine's Church in Latvia
 - \$700.00 to International Health Partners for hospital in Tanzania (this includes the donation from both 2019 and 2020)
 - ♦ \$200.00 to Loaves and Fishes
 - \$400.00 to Youth for Christ
 - ♦ \$400.00 to Ecumenical Food Pantry at First Presbyterian Church
 - ♦ \$400.00 to the Salvation Army
 - \$500.00 to the Food for Backpack Program
 - \$500.00 to the effort to support the local Foster Care Program
 - \$400.00 to the Campus Ministry at Winona State University
 - \$400.00 to the Campus Ministry at Minnesota State University, Mankato

Altar Guild

2020 was a year of challenges and unexpected changes.

During the months of January and February, we were on track to continue familiarizing members with the changes initiated late 2019.

March 10th was the scheduled membership meeting with the focus on the rest of Lent, Easter and upcoming months coverage. However, the content of the meeting drastically changed course with the focus being how to incorporate the enhanced infection control guidelines (COVID-19) into the specifics of Altar Guild responsibilities. We discussed mask use; proper handwashing; glove use; disinfection of surfaces; social distancing guidelines (only 2 people in Sacristy at one time; communion preparation/serving (continued to use bread with wine/grape juice in individual disposable cups on communion trays); communication of illness symptoms (self, household member, other contacts). Details of how to incorporate these infection control measures needed to be outlined for the March 15th church services. By the way, these were the first and last in-house church services that we prepared for until later in the year.

Beginning with the August outdoor church services, individually packaged communion elements were made available for attending members. Initially, these were prepared in-house. Purchasing prepackaged individual communion sets became an issue with the backorders and delays. Within the next weeks, prepackaged individual communion sets arrived and made were available at future church services.

Careful planning as to how infection control measures could to be incorporated into every action was challenging at times as "normal was not normal." Highlights of the abnormal included distribution of the prepackaged communion sets in the Narthex did not seem like a friendly, welcoming gesture using mask, gloves and social distancing. Outdoor baptisms were performed, so preparation adjustments were made. With pastoral guidance, a plan was worked out for First Communion Sunday with the intent that youth could experience communion at the rail. Individual social distancing of the bread and wine/juice with communion served in family groups was done. The changes made to display and distribution of roses on All Saints Sunday was another example.

Appreciation is given to the support shown to this ministry - encouraging words; suggestion of ideas; contributions of time and donations.

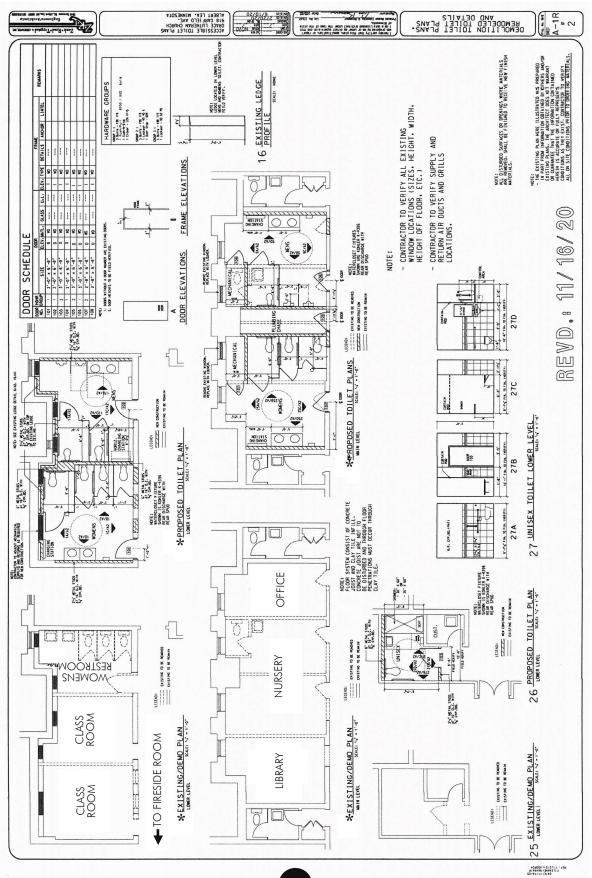

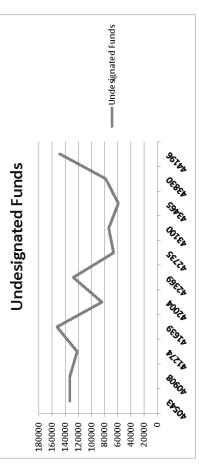
