January 30, 2022

### Call to Order

### Approval of the 2021 Annual Meeting Minutes

Motion by Tonia Palmer and second by Bruce Olson to approve the minutes of the annual meeting. The motion was approved.

### Gift Policy:

David Drommerhausen presented an overview of the new gift policy and invited questions. He emphasized the importance of having this policy especially in light of reduced giving. Without a major gift and PPP loans, the financial situation would have been much more precarious.

#### **Elections**

Motion by Bill Barber and second by Wes Dahl to accept the full ballot of nominations for 2022. The motion was approved.

#### **New Business:**

David Drommerhausen presented an overview of the proposed 2022 budget, and invited questions. Motion by Bill Barber and second by Jerry Vogt to approve the budget. The motion was approved.

### Adjournment

Motion by Bruce Olson and second by Lowell Peterson to adjourn the meeting. The motion was approved and the meeting adjourned at 10:34am.

Worship has looked different, leadership has made tough decisions in staffing and the way the staff spend their time, and that has been hard work, grief worthy work, even if it was necessary.

As we walk into 2023, there may be some nervousness about what's going to happen next. While being a pastor does not make me a fortune teller, I can assure you of this: God will continue to walk with us as we continue to serve God and our community in love and care. We trust that God will guide us through the mix of grief and hope as we continue to meet for worship, service, learning and shared community.

Our prayers for the future include hiring a music director, needed updates on our building, praying for our friends and neighbors, being present in worship, teaching our youth the joy of Christ in their lives in Sunday School and Confirmation, and keeping our eyes open as God reveals the kingdom to us in each of those adventures, maybe even adventures we have yet to see!

Thank you for being part of Grace, for walking this rough, unprecedented road, and for remaining part of the amazing work we do in God's name. Peace to you and I look forward to adventuring with you for another year.

### Vicar's Report

I spent January through August serving as Youth Director where we spent our Spring bringing back youth activities in a "post-covid" world, and our Summer on a youth trip to Buena Vista, Colorado with an incredible group of young people (and adult leaders) led by Pastor Dean.

On September 1st, my sixth anniversary of working at Grace, I transitioned into my Vicar (intern pastor) role. The last few months I have had the honor to move into this new role, learn what it means to be a pastoral leader and serve at Grace in a new capacity!

Part of this role includes meeting with a Lay Internship Committee. They will be intentionally walking with me during my internship. This includes: Heather Earl (chair), Paula Buendorf, Karen Hendrickson, Corrine Tims, Erika Youlden. If you have any questions regarding my role, you can reach out to any of them.

While I am part-time Vicar at Grace, I am also a full-time online Collaborate Learning student at Wartburg Theological Seminary. This past year I finished a unit in CPE (Clinical Pastoral Education), and I took many classes including: Being Body of Christ, Preaching, Pastoral Care, Spiritual Practice, Fieldwork, Hebrew Bible, 21<sup>st</sup> Century Leadership, Lutheran Confessions, and Teaching the Small Catechism. In Spring of 2023 I will be taking a J-Term trip to the Holy Land, Hebrew Bible 2, Global Church History, Word Image and Imagination, and Business Practices for Pastors.

Thank you to the people of Grace Lutheran who have supported and helped me as I continue this discernment into pastoral ministry. I am so thankful to get to bring all of you along on my seminary journey, and I am excited to continue to serve as part-time Vicar until spring of 2024.

## Parish Nurse Report

The practice of parish nursing focuses on a faith community. The parish nurse, in collaboration with the pastoral staff and congregants, participates in the ongoing transformation of the faith community into sources of health and healing. Parish nurses appreciate that all persons are sacred and must be treated with respect and dignity. The parish nurse serves the faith community, creating safe environments for healing, while advocating with compassion, mercy, and dignity.

Since the pandemic, the parish nurse ministry has looked a little different. The congregation is reminded weekly in the bulletin or Grace Notes that they should contact the pastors or the church office if they are scheduled for surgery, hospitalized, or undergoing changes in their medical conditions and requesting to have pastoral care. The pastors per your request will call on you and then it will be determined as to your situation if you'd care to have the parish nurse call on you also. At this time the pastor will make this referral to the parish nurse and a visitation schedule will be set up.

The parish nurse continues to make about 3-4 visits weekly during her Monday office hours, providing the sacrament of communion when requested. These visits take place in private residences, nursing care facilities, hospitals, and the church. I continue to make numerous phone calls and send cards to those that have been on our weekly prayer list and those that have experienced grief and loss.

In the past couple years, we have not been able to utilize the cookie ministry, so store bought and prepackaged treats have been provided during visits. The parish nurse has been known to deliver meals from restaurants or local grocery stores to those in need. I have provided transportation on occasion for medical appointments or offering links to those in need to the Salvation Army to assist with housing or food, as well as make referrals to local agencies for assistance with medical care, housing needs, utility assistance, etc.

We no longer have an active visitation team; however if you would like to be a part of visitation, please contact Pastor Shane with your name and when you may be available. Visitation may change soon with the need for volunteers to extend the ministry and love shared to others that are not able to attend church with us anymore.

## Food for Backpack Report (formerly LEAN)

"For I was hungry, and you gave me food, I was thirsty, and you gave me drink, I was a stranger and you welcomed me." Matthew 25:35

With the generosity of our Grace members, our friends from many other area churches, our community, and our school social workers we are able to provide weekend backpack meals for 576 students in grades preK-7 and the Alternative Learning Center.

This much needed program has once again expanded.

A quick story...Katie, our social worker called me one day this Fall and said that 2 of her students had asked if they could please have a packet of food for their preschool siblings. I know, heartbreaking. So, I told her to just give them an extra packet each week until we could figure something out. That same week the director of the #241 preschool called to ask if they could somehow be included in the FFB program and that they had 74 families that were in need. WOW! We had just submitted a grant application to the Hanson Family Foundation asking for \$10,000 but we didn't know if or when we would receive it. We were about to place our second food order and a decision needed to be made. We decided to include the preschool in the order, praying that we would get the grant. God answered our prayers and we did receive the grant so the preschool is funded for this year without a church sponsor. We continue to look for a church or two to sponsor this group of students, but church budgets are tight and we have not secured one as of now. The preschool director and teachers are thrilled to be included and they are so helpful in getting the food to these little dears each week.

We continue to use JA Foods out of Michigan to supply us with a variety of 4 meal packets. Of course, food and shipping costs have increased; it now costs \$170 to feed one student for the school year. We have applied for and received generous grants from The Otto Bremer Trust, The United Way and The Freeborn County Communities Foundation. With a total budget of over \$95,000, these grants supplement the program so that half of the cost is covered, with the exception of the preschool, which is fully funded by The Hanson Grant. Six other area churches—Zion Lutheran, Hayward Lutheran, Ascension Lutheran, First Lutheran, United Methodist, and Crossroads, along with Grace support the elementary schools, the middle school and the ALC. Grace, partnered with Zion, supports 108 students at Hawthorne.

Showing the children of our community that we care about them and their wellbeing helps them to have a feeling of belonging and a sense of security. We care about them and we want them to be successful learners. Thank you again for your donations, your volunteer time and your prayers. Blessings abound.

In October we started using Minnesota Maids to clean the floors in the entry ways, due to staffing issues in the custodial area. Also in October the lawn mower blew up, and was beyond repair, so it needed to be replaced. With the help of your THRIVENT CHOICE dollars we replaced it with a new one with those funds. Next year we hope to replace the steeple lights with LEDs which should last much longer.

The purpose of the Grace Lutheran Foundation continues to receive from Grace Lutheran members or from the public, gifts, bequests or properties as may from time to time be given. Interest accrued from funds and investments returns, including realized and unrealized capital gains controlled by the foundation, may be designated by the board to be used for missions, education or other specific projects of Grace Lutheran Church and its gospel outreach.

We are grateful for the collaborative work of Perry Loge and Marsha Smith and for the in-house audit that was completed for the year ending 2022. The foundation's main source of income was, again, the farmland rental monies. We are entering into a new contract for a term of one year. We also have income from a contract with Bent Tree Phase Two Wind Farm project through Alliant Energy.

Monetary support was again given in the form of scholarships to students from our congregation attending a Lutheran college. We are also currently financially supporting Ashley in her seminary education. The board provided support for the youth trip to Noah's Ark in Colorado and other support for the youth. The Foundation opens a Mission Investment Fund account valued at \$50 for every newly baptized member.

As we look ahead to 2023, we prayerfully consider the needs of Grace Lutheran Church and continue to provide appropriate financial support for the congregation, its ministry programs and gospel outreach.



## Grace Gifting Policy

### Grace Lutheran Church Gift Policy Summary

This document is a brief summary of the **full** Gift Policy adopted by Grace Lutheran Church, intended to offer an overview of how this congregation will handle cash and non-cash gifts offered over and above regular giving. <u>Donors are encouraged to bless this congregation's present and future with gifts free of restrictions.</u> The full policy is available in the church office or on <u>www.gracealbertlea.org</u>

The Finance Committee of Grace Lutheran Church has responsibility for reviewing gifts and shall make decisions and/or form recommendations to the Church Council regarding acceptance and use of gifts offered to the congregation, using the guidelines of the current Gift Policy.

The Finance Committee will consider gifts of cash, gifts through beneficiary designation (e.g., bank accounts, annuities, endowments, life insurance policies, etc.), marketable securities, bequests, real estate, other non-cash gifts and in-kind donations.

As a general rule, Grace Lutheran will convert all gifts to cash.

Valuation of non-cash gifts to Grace Lutheran shall be the responsibility of the donor or the donor's estate.

Unrestricted gifts with a value less than \$25,000 shall be used in the general fund.

Unrestricted gifts with a value <u>equal to or greater than</u> \$25,000 shall have the acceptance and use decisions recommended by the Gift Policy as follows:

This congregation shall offer a contribution of 10% of the total gift to the Mission Giving Fund for distribution by the Mission Team, 45% of the total gift will go to the endowment fund, and the remaining 45% will go the general fund.

Gifts with specific donor-defined restrictions will be considered on a case-by-case basis by the Finance Committee in consultation with the Church Council. Donors who choose to restrict the use of a gift to Grace are strongly encouraged to complete a <u>Restriction and Release Form</u>.

Memorial and honorary gifts of any size given to Grace Lutheran shall be handled according to <u>section VII</u> of the Gift Policy.

Donors are encouraged to consult with their personal tax advisor, estate attorney and/or financial advisor for specific tax, legal, and investment information. <u>Grace Lutheran</u> does not provide any tax, legal, or investment advice.



At our 2022 Synod Assembly, we gathered under the theme *Imagine: Endless Possibilities in God's Grace*. As we live into the future God has for us, we see what we had once only imagined start to take shape in concrete ways.

This year has brought a new way of meeting the needs of congregations in transition as we have explored various models for pastoral ministry. Most prominent among them is what we call a Bridge to Settled model. This new model allows congregations to work with a Bridge pastor (different than an intentionally trained interim) while forming a call committee and engaging in the call process with the understanding that both the pastor and congregation are open to transitioning from the Bridge into a settled call. It is not the right model for every congregation, but it has greatly benefited many.

We have also seen a gentle uptick in individual congregations exploring partnerships of all kinds. Some congregations are forming new joint parishes, others are working together to meld two part-time calls into full-time work for a single candidate, and still others are merging weekly confirmation classes. More and more of our congregations are realizing the profound benefits and joy of collaboration.

It has been fun to walk alongside folks as they lead their congregations into new ways of being the People of God in their community in this time and place.

As 2023 approaches, I remain ever hopeful for all that the Spirit will continue to do in and through us as the Southeastern Minnesota Synod. Looking ahead to our next Synod Assembly, I am excited to announce that we will be joined by Drs. Susan Brower and Matt Bloom. Drs. Brower and Bloom will give us tools to understand our communities as they are presently and as they are projected to be. They will also explore ways congregations can ignite flourishing in the communities to which they are called.

I am excited to continue imagining alongside each of you as we discern what God is doing in our midst and calling us to do. What a wonderful time to be the church together for the sake of the world.
